



**REQUEST FOR EXPRESSION OF INTEREST: PIPE STORAGE AND
TRANSPORTATION SYSTEM FOR MAIN LOGISTICS CONTRACTOR
FOR EACOP**

E.A.L.S Limited Tanzania as the Main Logistics Contractor for the EACOP Project, invites experienced and reputable organisations to express their interest in providing Pipe Storage and Transportation System to the East African Crude Oil Pipeline (EACOP) project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

We are looking for a versatile yard storage solution for the storage of 18 meter pipe with adjustment capacity to manage pipe diameters ranging from 200mm to 800mm. Storage solution should be a base rack type that can accommodate safely a pipe stack of up to nine (9) pipes high with pipe weighing up to 6.5 metric tonnes. Equipment should be resistant to oil and moisture, mobile, easy to assemble, disassemble, be able to change configuration and store without use of lifting equipment.

Racking should comprise of the following;

- Bottom rails – Steel reinforced polyurethane compound withstanding 40,000kg at temperatures in excess of 60° Celsius without deformation or degradation.
- Connecting blocks – Polyurethane Blocks with pipe supporting face angle of 92° that can be easily connected to the supporting rail, suitable for coated pipe surfaces and adjustable to accommodate varying pipe sizes.
- Anti-skid rubber mat 8mm-10mm thick and at least 300mm wide to lay under the pipe rails.
- All equipment must be available for use in Tanzania by 30/08/2022.

MINIMUM REQUIREMENTS:

Companies expressing their interest are invited to document their request with:

- Proof of registration with the Tanzania Revenue Authority and Tax (TRA) Clearance Certificate for the latest year available.
- EWURA Local Supplier Service Provider (LSSP) completed registration is highly recommended
- Compliance with Local Content Regulations, 2017 and Local Company definition
- Latest Filed Annual Returns together with the payment receipt
- Copies of government issued IDs for all shareholders
- Relevant ISO & industry certification; company policies and procedures i.e. HSE, AML, Human Rights etc
- Certificate of incorporation/ Registration from the registrar of companies (BRELA)
- Memorandum and Articles of Association;
- TIN Certificate; All Valid Business License and Permits
- Recent Audited Financial statements
- Current and past references; relevant experience & insurance certification; CSR projects
