



EAST AFRICAN CRUDE OIL PIPELINE

REQUEST FOR EXPRESSION OF INTEREST FOR THE RENTAL OF COMMERCIAL / OFFICE SPACE FOR THE EACOP PROJECT REF. NO. 0010006583

TOTAL East Africa Midstream B.V. (Company) Tanzania, an Oil and Gas company, invites experienced and reputable Companies to express their interest in providing rental office space for the East African Crude Oil Pipeline (EACOP) project teams.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is nearly 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

The Project requires commercial / office space to accommodate its growing corporate and Project teams. The teams are anticipated to grow rapidly beginning in Q3 of 2021 and nearing 300 people within the coming year. 1000 square meters of

space will be needed by Q3 2021 and expanding to between 3,500 to 3,700 square meters over the next two-year period.

Preferred location will remain in or near the Masaki and/or Oyster Bay neighbourhoods and must have adequate parking facilities. Life safety and security aspects including adequate means of fire & smoke protection, emergency evacuation and mustering space, secured entry with guards' area, kitchen and hygiene facilities. A mixture of private and shared offices and open plan workspaces will be considered. Meeting room facilities of various sizes are required.

MINIMUM REQUIREMENTS:

Companies expressing their interest are invited to document their request with:

- **Proof of legal registration in Tanzania.**
- **Proof of a valid business license.**
- **Proof of registration with the Tanzania Revenue Authority (TRA) (TIN and VRN) and Tax Clearance Certificate for the latest year available.**
