banking services in Uganda.

The East African Crude Oil Pipeline (EACOP) Project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda traversing ten (10) districts, comprising Hoima, Kikuube, Kakumiro, Kyankwanzi, Mubende, Gomba, Sembabule, Lwengo, Rakai and Kyotera.

## **BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES**

The Company wishes to open bank accounts in two commercial banks in Uganda. The accounts will solely be used to process Company domestic payments via electronic transfers. Payments will be made in USD or in UGX, in favour of third-party vendors, local administrations and employees.

The services exclude cross-border payment, petty cash, overdraft, loan, deposit, and other financial instruments. In addition to the global pricing, consideration will be given to local content, number of branches, competitive FX, commercial assistance, technical support, cut-off and turnaround time, ability to meet requested value date, bank rating and, the willingness of the bank to participate in the intended EACOP corporate's external debt financing.

- Legal entity documentation including certificate of incorporation and registration, license, certification to undertake Banking services
- Proof of registration with the Uganda Revenue Authority (URA) and current Tax Clearance Certificate.
