TOTAL East Africa Midstream B.V. (Company) Uganda, an Oil and Gas company, requires the services of an experienced and reputable CONTRACTOR for the design and construction of Replacement houses in support of the Resettlement Action Plan (RAP) component of the East African Crude Oil Pipeline (EACOP) Project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 kilometers (km), of which 296 km will be in Uganda.

The section of the pipeline in Uganda will traverse ten (10) Districts, comprising Hoima, Kikuube, Kakumiro, Kyankwanzi, Mubende, Gomba, Sembabule, Lwengo, Rakai and Kyotera.

BRIEF DESCRIPTION OF THE SCOPE OF WORK:

The Project requires land for the pipeline right of way (RoW) and Above Ground Installations — AGI's for the construction and operation of the crude oil pipeline. The project will lead to resettlement of some project affected persons for whom replacement house options will be offered.

COMPANY requires the services of a design and construction company (companies can collaborate for the provision of these services) to provide the following services:

 Housing architectural design and acquisition of all statutory approvals.

- Cadastral Survey and mapping of housing plots
- Earth works, site clearance
- Building construction works
- Monitor and report on QA/QC and HSE
- Interior and exterior finishes including landscaping
- Installation, and maintenance of electrical, mechanical, solar and drainage systems and extensions

The scope will require design and construction of approximately 150 to 200 houses spread across the 10 EACOP Districts in Uganda.

MINIMUM REQUIREMENTS:

Company/ Companies expressing their interest are invited to document their request with:

- Proof of current registration to the National Supplier Database for the year 2020-2021;
- Evidence of Company QHSE policy, procedure and process in compliance with applicable National and Industry standards for similar works
- Experience/performance in similar contracts locally and / or within East Africa
- Key suitably qualified, experienced and registered/ accredited lead personnel (i.e. Civil Engineer, Structural Engineer, Mechanical Engineer, Cadastral Surveyor, Architect)
- Proof of Financial capacity to deliver the services required
- Proof of registration with the Uganda Revenue Authority and Tax Clearance Certificate for the latest year.
