E.A.L.S Limited Tanzania as the Main Logistics Contractor for the EACOP Project, invites experienced and reputable organisations to express their interest in providing Lifting Operations Manpower Requirements to the East African Crude Oil Pipeline (EACOP) project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run to Kabaale in Hoima District, Uganda, from Chongoleani, Tanga Region in Tanzania. The length of the pipeline is 1.443 km, of which 1.147 km will be in Tanzania.

## BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

- A continuous service provision on a 24-hour, 7 day per week basis over 24 months in compliance with local labour laws
- Operate a fleet of 3 cranes (client owned and maintained) utilising requisite team of crane operators, supervisors, slingers, banksman, flagmen
- Crane Operators, slingers and banksmen to hold international certification (eg LEEA) – renewed annually
- Crane Operators to be trained in use of the client's specific load handlings attachments: Vacuum Lifter and gyroscopic motorized load stabilizer. Training to be recertificated annually

All personnel to be trained in Fire Safety and Basic First

- Aid.
- All personnel to hold valid Fit for Work Medical
- Personnel supplied with PPE Continuous competence development plan to be developed for all personnel

- Enough crane operators must be supplied so that operators do not operate for longer than 6 hours duration on any shift without hraak
- Provide quayside Lifting Operations Supervision personnel to hold internationally accredited certification (eq LEEA)
- Provide inspection personnel to conduct visual inspection of pipes during offloading
- Provide Flagman cover for vehicle movements (one Flagman on duty at any time)
- Local minibus transportation to ensure personnel arrive correctly for each shift
- Electronic attendance recording system
  - CSR project to run in conjunction with provision
  - Supply of lifting accessories and attachments confirming to international standards
  - Thorough Examination of lifting equipment in accordance with UK LOLER Regulations and international standards conducted by LEEA registered Third Party Inspection Company

## MINIMUM REQUIREMENTS:

- Proof of registration with the Tanzania Revenue Authority and Tax (TRA) Clearance Certificate for the latest year
