- A current copy of their own and main suppliers ISO 9001:2015 and 14001:2015 & OHSAS 18001 (ISO45001:2015) certification.
- Extracts from Supply Quality Management Procedures, showing how material quality control is implemented in the supply chain and/or identify what positive material identification is implemented in manufacturing process.
- Provision of audited financial reports (past two (2) years) ensuring adequate financial health of the business.
- Registration with the LSSP is strongly encouraged

Tanzania (Local Content Requirements):

- Application for registration with the EWURA Local Supplier Service Provider (LSSP) database at the time of the response to this EOI is strongly recommended.
- Compliance with Local Content Regulations, 2017 and Local Company definition.

Interested companies which meet the minimum requirements and have the capacity to provide the goods listed above should express their interest by sending together with the above listed documents an email to
