



# REQUEST FOR EXPRESSION OF INTEREST FOR PROVISION OF KITCHEN UTENSILS REFERENCE NO.: CPP-PROC-UG-031-0613

China Petroleum Pipeline Engineering Co., Ltd. (hereinafter abbreviated as CPP) as Pipeline, Feederline & Above Ground Installation Contractor for the East African Crude Oil Pipeline (EACOP) Project invites experienced and reputable Contractors to express their interest in providing **KITCHEN UTENSILS** to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda.

#### **BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:**

• Provision of Kitchen Utensils, which include but not limited to cutting board, pressure cooker, insulation barrel, sideboard, chef's clothes, teapot, disposable cup, etc. Detailed information refers to Appendix 3.
