

## REQUEST FOR EXPRESSION OF INTEREST: PROVISION OF ASSET CODING SERVICES REFERENCE NO. EOI 00000286

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies to express their interest in providing Asset Coding Services to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

## **BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES**

- The bar code labels should be readable by bar code readers.
- The barcode labels should be readily visible and readable from a normal viewing point.
- Physical verification to be carried out and reconciled to the existing asset register.
- Material: Very attractive .020" anodized aluminum face stock
- Attachment: Use 3M 467 permanent pressure-resistant adhesive for rapid application and tamper evident.
- Label Copy: High 'quality, durable, able to withstand extreme weather conditions between 100C to 850C, and solvent resistant, thin, and flexible enough to conform to most surfaces.
- Colors: Black graphics on a silver background.
- Sizes: 39mm x 13mm.
- Packaging: Delivered in sequential order, 100% no missing numbers.
- 10. A requisite card reader should be provided.

## MINIMUM REQUIREMENTS

Companies or organizations expressing their interest are invited to document their request with:

- Legal entity documentation including a certificate of incorporation and registration, trading license, and certification to undertake the services.
- Proof of registration to the National Supplier Database (NSD) maintained by the Petroleum Authority in Uganda. (A MUST)

- Proof of registration with the Uganda Revenue Authority (URA) and Tax Clearance Certificate for the latest year available
- Compliance with the Petroleum Midstream National Content Regulations, 2016.
- Experience, performance, and capacity in delivering the asset coding services outlined above, at a large scale in Uganda, in compliance with national and international standards
- Audited Financial Statements for the last three years.
- Evidence of a QHSE Management system, organization, and process in compliance with applicable Local and Industry standards for similar works.
- Proof of Anti-corruption, Anti-bribery, Compliance, and Human Rights policies.

Only the pre-qualified companies will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process.
