China Petroleum Pipeline Engineering Co., Ltd. (hereinafter abbreviated as CPP) as Pipeline, Feederline & Above Ground Installation Contractor for the East African Crude Oil Pipeline (EACOP) Project invites experienced and reputable Contractors to express their interest in providing **VEHICLE RENTAL SERVICE** to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

• Supply of vehicle rental services for project (such as 4X4 WD SUV, Pick-up, brand new.)

- NCAP-5star or ANCAP-5star certificate for vehicle.

APPENDIX 4 Technical Requirements of Vehicles for EACOP Project

21	All vehicles must be fitted with a fully functional lighting system including front and rear-turn indicators, a high-mount rear brake light, front headlights with high beam for night remote driving, taillights, reversing lights, hazard indicator lights; and for vehicles operating on site, flashing amber lights or alternative as specified by the business.	
22	Laminated front windscreens, fitted with adequate working windscreen washers and wipers must be used to keep windscreens clean.	
23	Roadside emergency kits and the contents of such must be provided where a risk assessment determines the requirement during the journey undertaken(Follow-up combined with practical considerations).	
24	Instrumentation must capture the local unit of measurement e.g., speedometer (kilometres/miles).
