East African Crude Oil Pipeline (EACOP) Ltd, an Oil and Gas company, invites experienced and reputable companies or organizations to express their interest in provision of Events Management Services for the East African Crude Oil Pipeline (EACOP).

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda. In Uganda the pipeline will traverse ten (10) districts comprising Hoima, Kikuube, Kakumiro, Kyankwanzi, Mubende, Gomba, Sembabule, Lwengo, Rakai, and Kyotera.

- Proof of registration with the Uganda Revenue Authority (URA) and Tax Clearance Certificate for the latest year available
- Proof of registration with the National Social Security Fund (NSSF)
- Evidence of Health, Safety, Security, Social, and Environmental Management including compliance with regulations (Workplace registration with the Ministry of Gender, Labor and Social Development) risk management, and competence and training of workers
