- Perform dispatch duties for empty vehicles and receive loaded vehicles
- Prepare report summary for trucks received/dispatched on daily basis
- Conduct driver safety briefings at MCPY and ensuring that the correct PPE is worn.
- Ensure that drivers and workers adhere to respective MCPY health and safety regulations
- To carry out Risk Assessment for each unlashing and provide guidance on precautionary measures to be taken by drivers, and offloading officers in order to ensure workers' safety at site
