E.A.L.S Limited Tanzania as the Main Logistics Contractor for the EACOP Project, invites experienced and reputable organisations to express their interest in providing on call handling equipment services to the East African Crude Oil Pipeline (EACOP) project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

- On-Call handling equipment service: availability and readiness for rapid deployment of handling equipment on short notice.
- 48-hour notice availability: guaranteed service availability within 48 hours of notification.
- Mob/Demob in Dar es Salaam: capability to mobilize and demobilize within Dar es Salaam city limits.
- All equipment must adhere to technical, environmental, health, and safety regulations and be certified by third party.
- List of equipment type and capability overview: cranes, forklifts, hydraulic lifting devices, powerpacks and jacks, side loaders, special attachments, and clamps

- Proof of registration with the Tanzania Revenue Authority and Tax Clearance Certificate for the latest year available

- Compliance with Petroleum (Local Content) Regulation, 2017 and Local Company Definition for Tanzania.
- Latest filled Annual Returns together with the payment receipt.
- Copies of government issued IDs for all shareholders.
- · Company policies and procedures i.e. HSE, AML, Human Rights etc.
- Recent Audited Financial statements.
- Current and Past references; relevant experience.
