

**REQUEST FOR EXPRESSION OF INTEREST FOR PROVISION OF CATERING SERVICE FOR MAIN CAMPS AND
PIPE YARDS (MCPYs)
REFERENCE NO.: CPP-PROC-TZ-081-0118**

China Petroleum Pipeline Engineering Co., Ltd. (hereinafter abbreviated as CPP) as Pipeline, Feederline & Above Ground Installation Contractor for the East African Crude Oil Pipeline (EACOP) Project, invites experienced and reputable Contractors to express their interest in providing catering service to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

Note: Interests can be expressed for one or more camps, each camp will choose at least one catering service provider and one food supplier.

MINIMUM REQUIREMENTS:

Companies or organizations expressing their interest are invited to document their request with:

- Proof of registration with the business registration and licensing agency - BRELA
- Proof of registration with the Tanzania Revenue Authority (TRA) and Tax Clearance Certificate for the latest year available.
- Proof of registration/application to the EWURA Local Supplier Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- Compliance with Petroleum (Local Content) Regulations, 2017, and Local Company definition for Tanzania.
- The company to be familiarized with IPIECA-IOGP requirements, particularly IOGP 397 and other Catering Standards as well as the organization to be fully conversant in establishing an HACCP system and maintaining as such.
- Fully filled Key personnel list with CV (Appendix 1) and list of production (Appendix 2) in the requested format. (Blank is regarded as an unqualified item.)
- Similar supplying experience within the last three years (Appendix 3) in the requested format.
- Copy of certificates of ISO 45001: 2018, ISO 22000: 2018, ISO 9001 or equivalent of them is advantageous.

Note: Catering Companies are required to be registered in the LSSP database, while their food suppliers will function within the framework of the main food supplier and are exempted from the LSSP registration.

Companies which have the ability, capacity, and resources to implement the activities listed above should express their interest by sending together with the documents stated in the above section through an email to supplierdata1@cpptz.com (Max. Email Size: 20 MBs, all documents must be submitted in the English language) on or before 24:00 hours East African Time (EAT), on 02nd February 2024. CPP reserves the right not to consider companies that submit an incorrect email subject and the incorrect format of Appendix 1, 2 and 3.
