EITS Contractor (Electrical Instrumentation and Telecommunications Systems) for the EACOP project, invites experienced and reputable companies to express their interest in the provision of Fabrication Yard Rental

## SCOPE OF WORK:

- Rental of 10,000 sqm Industrial Fabrication Yard, land plot with direct access to tarmac public roads.
- The covered workshop should have at least 20x100m (minimum 4,5m height) of single volume shelter, free access from both ends. minimum 4mx4m doors.
- Rental duration 12 months approximately.
- Targeted Location: metropolitan area of Dar es Salaam (TZ)
- Building should be fully licensed (permit), fenced, permanent security, with access control and all utilities available (power, water, wastewater, internet), 80% surface should be compacted crashed stone.
  - <u>Key Support Amenities</u>: offices for 10-12 persons, kitchen (and/or accessible restaurant) and hygiene facilities (2 restrooms) Safety & Security Systems (e.g guards, fire protection, smoke detection, emergency evacuation & mustering space); stand-by generator minimum 150 kVA;

- Proof of registration with the Tanzania Revenue Authority: TIN, VAT Registration, Tax Compliance Certificate
- Proof of registration/application to the EWURA Local Supplier Service Providers (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- Compliance with Petroleum Local Content Regulations, 2017; The Petroleum Act 2015 and Local Company definition for Tanzania.
- Provide evidence of registration, certification and compliance from relevant regulators and food-handling bodies
- Provide a Company Profile, Audited financial statements for the past 3 financial years and a Letter from your Banker(s)
- At least 5 years of demonstrable experience and financial capacity in delivering such services.
- Evidence of organization H3SE Management Systems, Policies, and Procedure.
- Statutory documentation: proof of Land ownership, proof of Land taxes paid to date, OSHA certification, Department of Fire certificate, NEMC approved EIA;
- Copy of Certificates of ISO 9001, ISO 14001, ISO 45001 or equivalent (as applicable)
