China Petroleum Pipeline Engineering Co., Ltd. (hereinafter abbreviated as CPP) as Pipeline, Feeder line & Above Ground Installation Contractor for the East African Crude Oil Pipeline (EACOP) Project invites experienced and reputable Contractors to express their interest in providing **SITE Preparation and Earthworks, Civil Works, Road and underground networks Works, Building and Architectural Works for Above Ground Installations (PS5)** to the EACOP Project.

**The Expression of Interest (EOI) is being re-advertised due to circumstances beyond our control.**

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

**BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:**

**Location:**

**PS 5: Kamando, Igunga, Tabora**

- SITE Preparation and Earthworks' activities include, but not limited to: a) Setting out. b) Tree felling. c) Bush clearing. d) Demolition and removal of any pre-existing structures. e) Topsoil removal separation. f) Placement of temporary protection/drainage. g) Cut and fill. h) Installation of geotextile. i) Soil improvement and substitution as necessary. j) Side slopes cut and fill. k) Management of all surplus excavated materials as waste. l) engineering soil material & transportation from borrow pit and extra /waste material to dispose pit. m) Sediment Pond. n) Landscaping.
- The Civil Works construction encompasses the following: a) Concrete substructures/foundations (slabs, shallow/deep foundations). b) Pipelines anchor blocks. c) Concrete sumps, valve pits, draw pits, transformer bay, separators, catch basins, etc. d) buildings (modular or concrete/blockwork field erected. e) Ponds, storm water basins with membrane or concrete waterproof lining.
- Road and underground networks Works encompass: access road, plant road, pave, unpaved water supply and drainage pipe (HDPE, GRE etc.).
- The Building and Architectural Works encompasses reinforced concrete buildings, blockwork buildings and fences. Work activities include all main construction and interior decoration as required.

4. Compliance with Petroleum (Local Content) Regulations, 2017, and Local Company definition for Tanzania.
5. Fully filled key personnel list with CV and equipment list of production and inspection in requested format. (Blank is regarded as an unqualified item.)
  - 5.1 Please provide key personnel list, the minimum requirements for key personnel are as follows: one Project Manager, one Civil QC, one Environment Coordinator, one Safety Engineer, one Community Liaison Officer (CLO), format refer to Appendix 1;
  - 5.2 Please provide the aforementioned key personnel CVs;
  - 5.3 Please provide owned equipment list, format refer to Appendix 2;
  - 5.4 Please provide photos and owned certificates (Motor Vehicle Registration Card).
6. Similar supplying experience within the last three years in the requested format.
  - 6.1 Please provide similar experience within last three years, format refer to Appendix 3;
  - 6.2 Please provide scanned CONTRACT for completed project or LETTER of AWARD for ongoing projects, completion certificate (if any), appreciation letters (if any) etc.
7. Copy of certificates of ISO 9001, ISO 45001, ISO 14001, or equivalent of them (OSHA).
8. Proof of registration in Contractors Registration Board (CRB) with Class One in Civil Discipline.
