



REQUEST FOR EXPRESSION OF INTEREST FOR THE PROVISION OF RIVER AND WETLAND CROSSINGS CONSTRUCTION WORKS FOR PIPELINE REFERENCE NO.:CPP-PROC-UG-067-0123

China Petroleum Pipeline Engineering Co., Ltd. (hereinafter abbreviated as CPP) as Pipeline, Feederline & Above Ground Installation Contractor for the East African Crude Oil Pipeline (EACOP) Project invites experienced and reputable Contractors to express their interest in providing **River and Wetland Crossings Construction Works for Pipeline** to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

The EACOP requirements for the **River and Wetland Crossings Construction Works for Pipeline in Uganda, the Scope of Work** will include the provision of:

 Right of Way (ROW) and Additional Temporary Work Space (ATWS) Preparations: a) Marking of ROW and ATWS; b) Drainage within the width of the ROW; c) Surface vegetation clearance over the complete width of the ROW and ATWS;
d) Top soil removal, separation, disposal, protection; e) Placement of temporary protection; f) Installation of bog mats (if necessary).

2. Protective Measures: Before construction, the following protective measures are installed: a) Diversion channel; b) Cofferdam; c) Sediment barrier; d) Interceptor dike; e) Slope breaker; f) Trench plug.

3. Temporary Access Road: Temporary access road's **a)** Upgrade or new build, **b)** Maintenance.

4. Ditching Works: a) Excavating; b) Soil disposal; c) Shoring; d) Trench dewatering; f) Sheet-pilling (if necessary).

5.Padding / Backfilling: The trench shall be backfilled in layers and compacted bell holes and other excavations. Material used for backfilling shall be appropriately screened or procurement.

6.Cleaning-up / Reinstatement: **a)** Removing cofferdam, diversion channel, temporary access road and necessary protective measures; **b)** Restoration of riverbed and river banks; **c)** Collection of excess materials and wastes; **d)** Setting water-body Bank protection; **e)** Marker posts installation; **f)** Re-vegetation.

7.H3SE: Comply with and implement all Health, Safety, Social, Security and Environment requirements of the EACOP project, including but not limited to: **a**) Provide sufficient dedicated H3SE management personnel; **b**) Provide sufficient PPE, portable toilets, medical facilities, medicines, security personnel, vehicles with high level of protection, etc., **c**) Set up safety protection facilities, **d**) Set up site closure, **e**) Comply with the requirements of the Environmental and Social Management Plan and the Environment and Social Impact Assessment, **f**) Comply with the implementation standards and requirements of the EACOP project.

MINIMUM REQUIREMENTS:

Companies or organizations expressing their interest are invited to document their request with:

- Proof of business registration and business license for Uganda.
- Proof of registration with the Uganda Tax Revenue Authority.
- Proof of registration with the National Suppler Database (NSD) for Uganda.
- Compliance with the Petroleum Midstream National Content Regulation # 34,2016 for Uganda.
- Fully filled Questionnaire, Key personnel list with CV(Appendix1)
- Equipment list of production and inspection (Appendix2) in requested format. (The amount of <u>Long Arm Excavators,</u> <u>Wetland Excavators, Piling Excavators, Water Pumps</u> must be adequate.)
- Similar experience of River and Wetland construction within last three years (Appendix3) in requested format.





- Copy of certificates of ISO 9001, ISO 45001, ISO 14001 or equivalent of them.
- Tax Clearance Certificate for the latest year available.
- Audit Financial Statement for latest 3 years.

Companies which have the ability, capacity, and resources to implement the activities listed above should express their interest by sending together with the documents stated in the above section through an email to **biddingbox@cpptz.com** (Max.
