

**REQUEST FOR EXPRESSION OF INTEREST FOR PROVISION OF CONSTRUCTION WORKS FOR
OPEN-CUT RIVER CROSSING
REFERENCE NO.: CPP-PROC-TZ-085-0201-C1C4**

China Petroleum Pipeline Engineering Co., Ltd. (hereinafter abbreviated as CPP) as Pipeline, Feeder line & Above Ground Installation Contractor for the East African Crude Oil Pipeline (EACOP) Project invites experienced and reputable Contractors to express their interest in providing **construction works for open-cut crossing** to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

- Prior to excavating the river, construct cofferdams and diversion channels to provide a dry working space for pipeline crossing.
- River excavation must meet design requirements, with a minimum depth of 2.56 meters at the deepest point of the riverbed, including slope treatment for trench formation and earthwork transportation.
- Install weighted blocks to stabilize and secure the pipelines.
- Upon completion of pipeline installation, backfilling and restoration work for the riverbed, embankments, cofferdams, diversion channels, etc. (excluding hydraulic protection).
- Restore the natural landscape and surface features impacted by construction activities.

MINIMUM REQUIREMENTS:

Companies or organizations expressing their interest are invited to document their request with:

- 1) Proof of registration with the business registration and licensing agency - BRELA
- 2) Proof of registration with the Tanzania Revenue Authority (TRA) and Tax Clearance Certificate for the latest year available.
- 3) Proof of registration/application to the EWURA Local Supplier and Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- 4) Compliance with Petroleum (Local Content) Regulations, 2017, and Local Company definition for Tanzania.
- 5) Fully filled key personnel list with CV and equipment list of production and inspection in requested format. (Blank is regarded as an unqualified item.)

5.1 Please provide key personnel list, the minimum requirements for key personnel are as follows: one Project Manager, one Civil Engineer, one Civil QC, one Environment Coordinator, one Safety Engineer, one Community Liaison Officer (CLO), and one Human Resources (HR), format refer to Appendix 1;

5.2 Please provide the aforementioned key personnel CVs;

5.3 Please provide owned equipment list, the minimum requirements for equipment are as follows: excavators with

a capacity of 20 tons or above, ensuring a minimum of 10 units or more, format refer to Appendix 2;

5.4 Please provide photos and owned certificates (Motor Vehicle Registration Card).

6) Similar supplying experience within the last three years in the requested format.

6.1 Please provide similar experience within last three years, format refer to Appendix 3;

6.2 Please provide scanned CONTRACT for completed project or LETTER of AWARD for ongoing projects, completion certificate (if any), appreciation letters (if any) etc.

7) Copy of certificates of ISO 9001, ISO 45001, ISO 14001, or equivalent of them (OSHA).

8) Proof of registration in Contractors Registration Board (CRB) with Class One in Civil Discipline.
