

## REQUEST FOR EXPRESSION OF INTEREST FOR: PROVISION OF TECHNICAL ASSISTANCE SERVICES FOR ENGINEERING WORKS

EITS Contractor (Electrical Instrumentation Telecommunication and Security Systems) for the EACOP project, invites experienced and reputable service providers to express their interest in the Provision of Technical Assistance Services for Engineering Works.

## **SCOPE OF SERVICES:**

- The targeted commissioning activities will include, as a minimum, the following:
  - o Commissioning preparation and Functional Tests
  - o Operational Tests and End to End Testing
- Additional Onsite activities include but not limited to:
  - Verification of all cable physical integrity, routing (segregation), supporting, bending radius, termination, labelling, core marking and connection (torquing) of all cables, including Electrical Systems, Instrumentation and Control Systems.
  - Testing of all cable, such as continuity test, insulation test, high voltage withstand test, loop check, OTDR test and the like.
  - LV electrical cable termination, cable labelling, core marking and connection at Transformers, Switchboards, Motor Control Centres (MCC's), Distribution Boards, Control Panels, Marshalling Cabinets, Termination Boxes, Junction Boxes and Equipment as per scope of supply,
  - Re assembly of all packaged units into shelters, electrical heat tracing sub stations, electrical substations, and instrument equipment rooms,
  - Performance of any remedial work for defective systems, and re-test as required.
- The work will be carried out in United Republic of Tanzania in the following districts Muleba, Masumbwe, Igunga, Ilongelo, Kiteto, Handeni and Tanga
- The duration of work is expected to be between August 2024 to December 2025.

## **MINIMUM REQUIREMENTS:**

- Proof of business registration and license(s) for Tanzania.
- Proof of registration with the Tanzania Revenue Authority: TIN, VAT Registration, Tax Clearance Certificate for the latest year available.
- Proof of registration/application to the EWURA Local Supplier Service Providers (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- Proof of registration with Engineering Registration Board and Contractors Registration Board
- Compliance with Petroleum Local Content Regulations, 2017; and Local Company definition for Tanzania.
- Provide a Company Profile, Audited financial statements for the past 3 financial years and a Letter from your Banker(s).
- At least 5 years of demonstrable experience and financial capacity in delivering such services.
- Evidence of organization H3SE Management Systems, Policies and Procedure.
- Copy of Certificates of ISO 9001, ISO 14001, ISO 45001 or equivalent (as applicable).
