

REQUEST FOR EXPRESSION OF INTEREST: PROVISION OF CULTURAL HERITAGE EXPERTISE FOR PRE-CLEARANCE SURVEY (RE-ADVERTISED) REQ-00000166

East African Crude Oil Pipeline (EACOP) LTD ("COMPANY") invites experienced and reputable Ugandan companies to express their interest in conducting a pre-clearance survey along the EACOP right of way.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

COMPANY is seeking an experienced and reputable Ugandan company or organization to conduct a cultural heritage preclearance survey along the 296 km pipeline right of way in advance of the start of construction activities. This is to ensure that there are no graves, areas of cultural significance or visible archaeological sites or artifacts that can be affected by topsoil clearance of the 30 m pipeline right of way across ten districts of Uganda. The scope includes:

- Literature review of prior studies that have identified cultural heritage sites in the Project footprint.
- Conducting on-the-ground assessment of the full 296 km x 30 m pipeline right of way.
- Conducting excavations where cultural heritage that is found is deemed moveable.
- Prepare final report and conduct close-out meeting with findings and recommendations for EACOP management.

MINIMUM REQUIREMENTS

Companies or organizations expressing their interest are invited to document their request with:

Interested service providers should provide the following information:

- Company details including Certificate of Incorporation, Valid Trading License, Memorandum and articles of association.
- Evidence of a Quality Health, Safety and Environment Management system, organization, and process in compliance with applicable Local and Industry standards for similar works

- Demonstrate good understanding of Scope of Work for services to be provided (1 page max.)
- Experience, performance, capacity (including transport and human resources) and governance in delivering the services outlined above, at a large scale in Uganda, in compliance with national and international standards. (2 pages max.)
- Submission of registration certificate with the Uganda Revenue Authority (URA) and valid Tax Clearance Certificate
 - Proof of registration to the National Supplier Database (NSD) maintained by the Petroleum Authority in Uganda.
- Compliance statement of Local Content Regulations, 2016 and Local Company definition
- Proof of Anti-corruption, Anti-bribery, Compliance and Human Rights policies.
- Financial capacity to deliver the services required including submission of audited financial accounts for the last two year.

Only the pre-qualified companies will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process.
