On the 21st of July, EACOP's National Content representatives attended the Africa Global Logistics (AGL)/Bollore supplier forum at the Protea Hotel in Kampala to share opportunities for the provision of goods and services with suppliers in the transport, warehousing, and logistics sector. During the forum, participating companies also shared information on how they could work together and create synergies to advance transportation and logistics for the oil and gas industry in Uganda.



On the 27th of July, EACOP's National Content team facilitated a meeting with the Petroleum Authority of Uganda (PAU) and its AGI and Pipeline contractor China Petroleum Pipeline Engineering Ltd (CPP). The meeting purpose was to review CPP's National Content Addendum and receive any feedback and comments from the authority regarding their proposed plans prior to its official submission.



As EACOP's National Content was making head way in Uganda, EACOP's Local Content continued to engage in more activities on the Tanzanian side. On the 3rd of August, a representative from the Local Content team engaged in a university mapping activity with EACOP's main contractor for the Jetty and Load Out Facility Besix Ballast Nedam Ltd (BBN).
