(hereinafter as DOCG), as a CONTRACTOR for Storage & Terminal of EACOP Project, invites experienced and reputable contractors that have demonstrable capability, willingness, ability and availability to perform related works to express their interest in providing various services in the description to the East African Crude Oil Pipeline (EACOP) project.

The EACOP Project development involves the engineering, construction, operation and maintenance of a crude oil export pipeline crossing Uganda and Tanzania and an onshore Marine Terminal in Chongoleani, near Tanga Port in Tanzania.

There are Two (2) planned packages as shown below, Interested Companies may Express Interest for either Package 1 or Package 2 or Both;

Package-1: Provision of General Supplies (Ref: MST-TZ-20240516-001)

The services include but not limit to, the following:

- d. Supply of cleaning supplies, such as disinfectant wipes, laundry detergent, disposable napkins, toilet paper etc.

- g. Proof of registration/application to Local Supplier Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- h. Compliance with Petroleum (Local Content) Regulations, 2017, and Local Company definition for Tanzania.
