EKIHANDIIKO AHABARIKURWANIRIRA OBUGABE BW'ABANTU

Okusaraho okwa UN hali abarwanirira obugabe bw'abantu okw'omwaaka gwa 1998 kusoborora abarwanirira obugabe bw'abantu nka "omuntu weena rundi gurupu akusobora, nk'awe rundi omubwegese, wenka rundi nabandi, kukolera omubusiinge kulinda kandi nokuhagira obugabe bw'abantu".

Okuhikiriza okwehayo kwaakyo hali okulinda obugabe bw'abantu, liri iteeka lya EACOP kuha ekitinisa obugabe hali okwebazaho, obugabe kwitirana abandi kandi nobugabe kwesoroza omubusiinge, kandi nobugabe kutunga amahuure agakwasire hali omulingo EACOP ekuhikiramu abakukwatwaaho abatalibaniziibwe emirimo yekitongole.

EACOP emanyire okubaho omumateeka nomugaso ogwamaani ogw'abarwanirira obugabe bw'abantu gwabakukora (nk'obwekigambirweeho omukihandiko kya UN hali abarwanirira obugabe bw'abantu eky'omwaaka gwa 1998) omukuhagira nokulinda obugabe bw'abantu kandi nokweyongerayo kutekamu ekitinisa akachweeka keiteeka aka 30 (Article 30) nakachweeka keiteeka aka 3 (Article 3) akengenderwaaho ez'amahanga ga Uganda na Tanzania ezaha obugabe bw'okutunga ekyokugonza n'ebyokukora. EACOP kandi etamu ekitinisa eiteeka lya International Finance Corporation (IFC) eryatandikire kukora omumwaaka gwa 2018 hali okugarukwaamu hali okuholeera enzigu ebitongole ebirwanirira obugabe bw'abantu kandi nabakukwatwaaho habwa purojekiti.

"Nk'obwekiri kandi nokuhikiriza omutindo gwensi yoona hali obugabe bw'abantu, EACOP teikiraniza nokutinisiriza, okuharana, rundi kukozesa obukambwe hali abo abakuhagira obugabe bw'abantu omubusiinge bwiine akakwaate hali emirimo yaitu."

EACOP ekuseruza kuhagira okwetegerezangana kandi nokuhingisaniza ebitekerezo nabarwanirira obugabe bw'abantu omuntekaniza y'emirimo yaayo. EACOP etekamu ekitinisa ekyokuhikirira abakukwatwaaho boona habikwasire hansonga z'abarwanirira obugabe bw'abantu n'obugabe bwokukoleramu. EACOP ekutangira kukira muno okuhayo ebitekerezo byabakukwatwaaho abakuhayo okwetomboita rundi abakuha amahuure habintu ebikwasire habarwanirira obugabe bw'abantu (baitu nibalinda ensita yaabu). Nk'ekimu hali ebyebakukoraho, EACOP eija kweyongera kutunulira muno hansonga zabakazi na gurupu z'abantu abatakwesobora.

Nambere kikwetagisa, nk'okukisemberwe UN Guiding Principles on Business and Human Rights, EACOP ekuseruza kutekaho amaani kuletera abandi kutekamu ekitinisa ebigendererwa binu.

Nambere kiragambibwa nti haroho okutinisiriza; okuharana, rundi obukambwe hali abo abakurwanirira obugabe bw'abantu biine akakwaate hamirimo y'abu EACOP eija:

- Kutwaara obujunanzibwa aho n'aho kutunga amahuure ageyongereyo nikwo twetegerere ekika kyekyokango/obuzibu kandi obwekiraaba kiine akakwaate nemirimo ya EACOP.
- Kulinda ensita ey'abantu abakukwatwaaho.
- Nambere kikwetagisa, kuhikirira abakungu abakujunanzibwaho abakusobora kubamu ab'omukichweeka, ha disituriwikiti, abebembezi ba polisi, Petroleum Authority of Uganda (PAU) na Energy and Water Utilities Regulatory Authority (EWURA) omu Tanzania, Ministry of Internal Affairs omu Uganda na Ministry of the Interior omu Tanzania, Human Rights Commission (UHRC), na Tanzanian Commission for Human Rights and Good Governance (CHRAGG).
- Okulemera hakyetaago okuha ekitinisa obugabe bwabarwanirira obugabe bw'abantu kandi kukiramuno obwerinzi bwaabu, obulinzi, nobugabe hali obwinganiza omumateeka.
- Nambere kikwetagisa, kugambira ebitongole ebindi ebisobora kubamu UHRC, CHRAGG, na Embassy ezikwetagisa, ebitongole ebigaba obuyambi ebikwetagisa omumahanga ganu abiri.
- Nambere abakozi rundi aba konturakita ba EACOP baba nibo bakujunanzibwa emisango egyo, kina kurorwa nti okuseruliriza okukumara kukozerwe kusigikira hankora ya EACOP, oteireho nambere kikwetagisa kukoraho ekyabwangu kandi nokutekaho ekifubiro ekihikire.

KULEETA OKWERALIKIRIRA RUNDI OKWETOMBOITA NK'AKURWANIRIRA OBUGABE BW'ABANTU

EACOP etekamu amaani enkozesa yenkora yaayo eyokumaraho okwetomboita hali ensonga zoonza ez'okwetomboita ezikwasire hali emirimo yaabu halimu nokwetomboita okwabarwanirira obugabe bw'abantu:

- EACOP eina abakozi abajunanzibwa hankoragana y'abantu bekichweeka nekitongole kya EACOP (Community Liaison Officers) na banyampara baabu (Community relationship Supervisors) abaikara nibabungira ebichweeka nambere EACOP ekukorra kandi baitirana nabantu b'omukichweeka, kandi basobora kuhikirira kuhebwa okweralikirira, kuhayo ebirugireyo rundi kuhayo okwetomboita.

- EACOP eina n'esimu z'okuteraho etakusulirwa (omu Uganda 0800 216 000 kandi n'omu Tanzania 0800 780 068) eikaraho kandi egarukwamu buli kiro kuruga esaaha emu (1) eyanyenya kara kuhika esaaha ina (4) ezeikiro.
