
INTRODUCTION

East African Crude Oil Pipeline (EACOP) Ltd, is a special purpose company, that will construct and operate the East African Crude Oil Pipeline (EACOP), a 1,443 km long crude oil export pipeline that will transport Uganda's oil from Kabaale- Hoima in Uganda to the Chongoleani Peninsula near Tanga Port in Tanzania for export to the international market. This major export system, 296km in Uganda and 1,447KM in Tanzania), with a transportation capacity of 216,000bopd comprises of a 24 inch, insulated, heat traced and buried pipeline, six pumping stations (2 in Uganda and 4 in Tanzania), two pressure reduction stations and a Marine Storage Terminal. The Company is operated by its Shareholders Agreement in which TotalEnergies (62%), Uganda National Oil Company (UNOC - 15%), Tanzania Petroleum Development Corporation (TPDC - 15%) and CNOOC (8%) are shareholders. This update aims to provide the eight Authorities, 27 Districts/ Towns/ City Councils hosting the EACOP project with a status report on ongoing activities in their areas. The goal is to convey practical information about the current field activities, facilitating engagement and keeping the authorities informed.

Pipeline Route




Pipeline, Early Civil Works (ECW) of the Main Camps and Pipeyards (MCPY)

- CPP Pipeline Crossings Survey (57 sites) continues and due to heavy rain impacting access to some locations, is likely to continue into January 2024.
- JV Spek Early Civil Works (ECW) MCPY-16 & Nyanza Roads ECW MCPY-05 was paused due to heavy rains in December with restart scheduled from 2 January 2024.
- CPP MCPY-15 camp construction continues.
- ECW MCPY- 11, 10, 09, 08 & 06 are complete. Site have been handed over to CPP who are responsible for site security. MCPY-09 starts to host CPP equipment and materials.
- JV Spek ECW MCPY-07 completed, site handover over to CPP scheduled for early 2024. Walkdown and handover to CPP done early December.

- Kagongwa Road upgrade has continued through December, heavy rains expected to delay completion until early January.
- From 3rd week of December the first pipe delivery arrived at Dar es Salaam port and Main Logistics Contractor (MLC) started transporting pipe sections to the TIS.

Above Ground Installation (AGI): Pump Stations (PS) & Pressure Reduction Stations (PRS)

- CPP start PS4 (Bukombe), PS 5 (Igunga), PS6 (SIngida), and PRS 2 (Handeni) ECW preparation (site clearance activities). PS3 and PRS 1 site preparation works started as well.
- CPP local workforce recruitment started at PS-4, PS-5, PS-6, PRS-1 and PRS-2 to support these activities.



Thermal Insulation System (TIS) - the Coating Yard facility

- WASCO ISOAF continues pipe coating facility construction at the TIS while pipe sections begin to arrive at the TIS in readiness for initial pipe coating.
- WASCO ISOAF construction of TIS camp facilities, utilities and services to accommodate the TIS workforce and manage the coating yard operations continues.
- WASCO ISOAF community awareness raising on road safety continues, community content initiatives progress during December.

Main Storage Tanks & Terminals (MST)

 DOCG continues site preparation for the main construction phase, also impacted by heavy rains during December.
 Tank A construction started; foundation excavation started this month. DOCG routine engagements with all Chongoleani peninsula communities continue with focus on completion of road upgrade to the MST site, preparation for and increasing recruitment of local labour in advance of main construction activities in January 2024.

Jetty

 BBN piling activities continue, 7 permanent piles completed. Test piling works at location 2 completed and preparation works for location 1 ongoing.



EACOP EXTENDS AID TO MUDSLIDE VICTIMS IN HANANG

EACOP donated 1,000 bags of cement to support mudslide victims in Hanang District, Manyara Region.

Speaking during the event, the Regional Commissioner of Manyara, Ms Queen Sendiga, said, the recent calamity in Hanang has left our communities in dire need, and the humanitarian aid from EACOP comes as a great help during these challenging times. We appreciate their swift response and support in our efforts to rebuild and recover from this tragedy.

The heavy rain in Hanang District triggered widespread flooding and landslides, particularly on the steep slopes of Mount Hanang, impacting areas around the towns of Katesh and Gendabi.

The EACOP Tanzania branch, Communications Lead, Ms Catherine Mbatia said, "As one of the districts where our pipeline traverses, EACOP recognises the responsibility to stand in solidarity with the communities affected by this tragedy," She added: "The core values of EACOP extend beyond our operational commitments.

LAND ACQUISITION UPDATES

Compensation Agreements Signing

The count of unsigned Pipeline PAPs has reduced from 81 to 80. Notably, one PD PAP from Geita, who had been absent for an extended period, has been located. Following the escrow review process, the individual has successfully signed the compensation agreement.

Additional Land Acquisition at MCPY 12-Kondoa & KP 961-Singida

For technical reasons, there have been two recent changes to the EACOP Project footprint with an additional 11 ha of land being required in Kondoa at MCPY 12 and a short reroute at KP 961 in Singida. The engagement, land delineation, assets and socio-economic surveys have been completed for these changes. Valuation reports were prepared and

approved by the Government Chief Valuer.

Compensation agreements preparation is completed.

Currently EACOP is waiting for gazettement of the Notice of Intention to Acquire Land prior to commencement of compensation agreement signing.

Transitional Support Services

Completed delivery of December Transitional support services for all regions. The support provided included actual food baskets for zone 1 and 3 regions (Kagera, Geita, Shinyanga and Tanga) and cash allowance transfers for zone 2 regions (Tabora, Singida, Dodoma and Manyara).

95% of eligible PAHs have received support in the month of December 2023. Pending PAHs are due to unsigned Compensation Agreements, and absence. Efforts to locate those who did not receive food baskets are underway.



Overall progress: Two rounds of Transitional support deliveries (actual food baskets and cash allowances) have been successfully delivered to eligible Pipeline, MST terrestrial and diver fishers PAHs.

LIVELIHOOD RESTORATION

Livelihoods Restoration Program (LRP)

Land preparation and planting, Maize Improvement, and Crop diversification (LRA1-3)

1024 Pipeline Project Affected Households (PAHs) in the Geita region received support for Livelihood Restoration Activities, covering activities like land preparation, crop planting, maize improvement, and crop diversification.

PAHs were provided with agricultural inputs (crop seeds, fertilizer, pesticides, and herbicides), participated in the training, carried out farming using agricultural best practices, and received key messages on entitlements. Ward and village leaders have been actively engaged in enhancing sustainable practices across the region.



These efforts- Livelihood Restoration Activities are underway in regions including Kagera, Shinyanga, Tabora, Manyara, Dodoma, Singida, and Tanga with both the Pipeline and Priority Areas.

Development of vegetable 'Kitchen' gardens and crop diversity and, Improved agriculture production

29 Project Affected Households (PAH) in Tanga City-Marine Storage Terminal (MST) were supported with best vegetable farming practices. 17 (59%) out of 29 harvested 780kg of vegetables including Amaranths, bunches, Okra, and Chinese Cabbage which enhanced PAH livelihood restoration by consuming part of the harvest and selling to earn income.

18 PAHs in Tanga city have been supported in the improvement of farming for crop produce, considered crops including groundnuts, cassava, mung beans, and sweet potato. VUNA Agribusiness- the contractor has been key in enabling and monitoring crop development at PAHs. 2 (100%) out of 2 PAHs

that opted for groundnuts harvested 450 kgs of groundnuts and 1 PAH that opted for sweet potato harvested 28 bunches of sweet potato. Crop management has been in progress to enable PAHs' optimal performance in improving cassava and mung bean production to 18 and 2 PAHs respectively, successfully, two Projected Affected Households have adapted for improved agriculture production by replanting mung bean, in 0.12 and 0.11 acres each, after harvesting produce that was supported by the project and crops are progressing well.

REPLACEMENT HOUSING

All 296 houses are complete and have been handed over to their respective PAPs with a global construction progress at 100%.



The conclusion of the house construction marks the beginning of a one-year warranty period. During this duration, the Project, along with their contractors, shall be responsible to remedy any identified defects that may arise from the replacement houses. Table below indicate the timeframe for the warranty period for each of the eight (8) pipeline regions.

STAKEHOLDER ENGAGEMENT – GOVERNMENT AND COMMUNITY

The focus of engagement in December was to provide a general project update, conduct a quarter-four traditional leaders workshop, support RAP teams on coordination and distribution of food baskets, support livelihood restoration contractors on farm input distribution, and

to support CPP contractors on different AGI and MCPY sites activities.

A total of 125 meetings were held, bringing together 2,412 stakeholders, of whom 742 (31%) were women.

Vulnerable Ethnic Groups Self-Identifying as Indigenous People

In this month, 23 meetings were held with Vulnerable Ethnic Groups self-identifying as Indigenous People. The team managed to engage 217 stakeholders, of whom 212 (27%) were women. Among these meetings, was a quarter-four traditional leaders meeting which was held in Arusha between the 13th to 15th of December.

Apart from providing the general project update, the workshop aimed at evaluating the implementation of EACOP's Plan for Vulnerable Ethnic Groups self-identifying as Indigenous People. The findings from these discussions were shared with the audience at the end of the workshop.



GENDER EQUALITY AND SOCIAL INCLUSION POLICY

East African Crude Oil Pipeline (EACOP) commits to respect and uphold women's rights and applicable laws in our business and organisational activities. This Gender Equality and Social Inclusion Policy defines and frames EACOP's commitments for the benefit of all stakeholders, internal and external.

This Gender Equality and Social Inclusion Policy is aligned with the EACOP Human Rights Policy which prohibits discrimination based on origin, gender, age, disability, gender identity or affiliation, as well as any form of harassment, forced/compulsory and child labour (EACOP Human Rights Policy, 2022). It also takes into consideration the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW) (1979) ratified by the Government of Uganda in 1985 and the Government of Tanzania in 1986.

PROJECT INDUCED IN MIGRATION

In Decmber 203, the last PIIM Working Group meetings were conducted and especially in Tanga identified as a hotspot location (meaning where PIIM phenomenon is likely to happen). During this meeting, Chongoleani leaders and Tanga City leaders confirmed to have potential other new 8 projects near to EACOP project area in Chongoleani peninsula. They asked EACOP PIIM team to share its best practices regarding PIIM with these new actors: recruitment processes, communication, field monitoring. It's a call for all stakeholders to take some collective actions in managing the potentially In-migrants with associated impact/risk on Environment, Health, Social, Economic, Security and Cultural because of the

new projects near any other EACOP project locations. Satellite imagery was also shared with the PIIM WORKING GROUPS. It was helpful to detect all buildings changes. Field verification allowed to see if there was a link with the EACOP project or not and to cross checked with the District Authorities. New residential buildings/private Residences, bars / restaurants and guest house were detected. This economic development is partly due to EACOP activities and the presence of a new workforce but it has to be highlighted that in migration has been very limited there thanks to a very clear and transparent recruitment process well explained and understood






Several non-compliances have been registered and are actively monitored for timely closure, addressing each based on the nature of the non-compliance. standards.











