E.A.L.S Limited Tanzania as the Main Logistics Contractor for the EACOP Project, invites experienced and reputable organisations to express their interest in providing Passenger Transport Services to the East African Crude Oil Pipeline (EACOP) project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

We are looking for companies interested in providing transportation service for our employees on a daily basis in specialised 20/25-seater bus in the morning travel from the town of Kahama to the WASCO ISOAF plant located 18 km from the Kagongwa junction, in the evening. Passenger vehicles (pick-ups/SUVs) can also be booked on an ad hoc basis to the site.

- Technical compliant vehicle with highest safety rating (preferably 5-star safety rating).
- · Qualified driver with certification on defensive driving, valid commercial driving license, and medical fitness certificate.
- Vehicle fuel management, IVMS Tracking, speed governor and vehicle maintenance record handled by the service provider.
- · Vehicle insurance plan cover up to date.
- · Interested supplier must have a proven track record in managing passenger transport activity.
- · Supplier must be customer centric and prompt in responding to requirements/ queries.

- Recent Audited Financial statements.
- · Current and Past references; relevant experience.
