#### INTRODUCTION

East African Crude Oil Pipeline (EACOP) Ltd, is a special purpose company, that will construct and operate the East African Crude Oil Pipeline (EACOP), a 1,443km long crude oil export pipeline that will transport Uganda's oil from Kabaale-Hoima in Uganda to the Chongoleani Peninsula near Tanga Port in Tanzania for export to the international market.


This major export system, 296km in Uganda and 1,447KM in Tanzania, with a transportation capacity of 216,000bopd comprises of a 24 inch, insulated, heat traced and buried pipeline, six pumping stations (2 in Uganda and 4 in Tanzania), two pressure reduction stations and a Marine Storage Terminal.

The Company is operated by its Shareholders Agreement in which Total Energies (62%), Uganda National Oil Company (UNOC - 15%), Tanzania Petroleum Development Corporation (TPDC - 15%) and CNOOC (8%) are shareholders.

This update aims to provide the eight Authorities in Tanzania, 27 Districts/ Towns/ City Councils hosting the EACOP project with a status report on ongoing activities in their areas. The goal is to convey practical information about the current field activities, facilitating engagement and keeping the authorities informed.



#### **Pipeline Route**



#### PROJECT CONSTRUCTION

#### Project progress highlights as of February 2024



### Pipeline, Early Civil Works (ECW) of the Main Camps and Pipeyards (MCPY)

- CPP Pipeline Crossings Survey completed.
- Nyanza Roads Limited near completion of MCPY-05 Early Civil Works.
- CPP (and sub-contractors) have begun storing equipment and mobilizing resources to begin camp construction at MCPY-06, MCPY-08, MCPY-10 and MCPY-11.
- MCPY-07 handover to CPP completed.
- CPP equipment and materials storage at MCPY-09.
- CPP MCPY-15 camp construction continues.
- JV Spek MCPY-16 Early Civil Works nears completion, 1 zone handed over to CPP for camp preparation.
- Kagongwa Road upgrade scheduled for completion in mid-March.
- Pipe deliveries from Dar es Salaam port to the TIS continue.
- BBN continues load out facility (LOF) and jetty construction.


### Above Ground Installation (AGI): Pump Stations (PS) & Pressure Reduction Stations (PRS)

- CPP continues PS4 (Bukombe), PS 5 (Igunga), PS6 (SIngida), and PRS 1, PRS 2 (Handeni) ECW preparation (site clearance activities). PS 3 access road is the most recent to start (February).
- CPP local workforce recruitment started at PS3 Access Road, PS-4, PS-5, PS-6, PRS-1 and PRS-2 to support these activities.

#### Thermal Insulation System (TIS) - the Coating Yard facility.

- WASCO ISOAF continues pipe coating facility construction at the TIS while pipe sections begin to arrive at the TIS in readiness for initial pipe coating.
- WASCO ISOAF community awareness raising on road safety continues, community content initiatives progress during December.
- TIS plant scheduled for operations 3rd week March with an inauguration event.





#### Main Tanks & Terminals (MTT)

- DOCG continues site preparation for the main construction phase. DOCG has cleared the MTT 4 tank sites with Tank A construction started; foundation excavation started this month.
- DOCG continues routine engagements with all Chongoleani peninsula communities.
- The road upgrade works from the A14 junction to MTT is completed with installation of road signs starting.
- DOCG have started recruitment of local unskilled and semi-skilled labour for the main construction phase.

#### **Jetty**

 BBN piling activities continue, 7 permanent piles completed. Test piling works at location 2 completed and preparation works for location 1 ongoing.

- Stakeholder engagement continues with the communities
  of Chongoleani peninsula on BBN jetty construction
  activities as well as engaging other marine operators and
  stakeholders with a presence near or traversing close to
  the BBN operations.
- EACOP Project Social team continues to observe and guide all Contractor stakeholder engagement activities in Project Affected Communities including the recruitment for unskilled and semi-skilled workers from the communities most local to the work.
- EACOP Cultural Heritage Monitors continue to observe all ground disturbance activities at MTT tanks and terminals (DOCG), PS 3 Access Road, PS6, PRS1, and PRS2 (all CPP).

## LAND ACQUISITION UPDATES

#### **Compensation Agreements Signing**

The number of unsigned PAPs remains 81 as of last month. Six unsigned compensation agreements claims are under review. Follow up with field teams, and village authorities to get updates on other unsigned cases ongoing.

#### Additional Land Acquisition at MCPY 12 - Kondoa & KP 961-Singida

Notice of Intention to Acquire Land (NOIA) signed by the Minister and the President but not yet gazetted. Follow-up with TPDC and Ministry of Land to get status of the NOIA gazettement.

#### **Transitional Support Services**

As of February 2024, 97% of eligible PAHs have received February transitional support deliveries. These include actual food baskets and cash transfers.

Categories of support differ from zone to zone depending on the calendar of distribution as shown below:

**Zone 1 regions** (Kagera, Geita and Shinyanga) severely impacted PAHs received actual food baskets, and partially impacted PAHs received cash transfers.

**Zone 2 regions** (Tabora, Singida, Dodoma and Manyara), all eligible PAHs received cash transfers.

**Zone 3 region** (Tanga), all eligible PAHs received actual food baskets.

Ongoing rainfall in Tanga region has hindered the timely delivery of actual food baskets, particularly in villages within Kilindi and Handeni districts, due to challenging access routes.

**Overall progress:** Five rounds of Transitional support services have been successfully delivered to eligible Project Affected Households in the Pipeline, MST terrestrial and diver fishers.

#### **Grave Removal Progress**

As of February 2024, 1,120/1,123 of the original Pipeline graves have been completed removed from the Project land.

Two (2) more new graves have been identified in the Pipeline Right of Way. This makes a total of 13 newly identified graves and a total of 17 unremoved graves. Supplementary valuation report for 11/13 newly identified graves approved by the Chief Valuer. Ongoing Signoff and disclosure of supplementary valuation report for 2/13 newly identified graves. Compensation Agreement Signing for the newly identified graves expected in mid-March 2024.

9/13 death certificate for the newly identified graves have been collected. Follow-up to obtain the remained death certificates ongoing.

#### LIVELIHOOD RESTORATION

#### **Livelihoods Restoration Program (LRP)**

#### LRA 1 - 3: Sustainable Agriculture

Livelihoods Restoration Program has been training Project Affected Households (PAHs) in sustainable agriculture practices. One of the Sustainable Agriculture practices LRP has adopted and has been training PAHs is Conservation Agriculture. This initiative aims to equip PAHs with the knowledge and skills needed to engage in farming methods that promote long-term environmental health and economic viability.

Through training sessions and capacity-building, PAHs learn techniques such as conservation farming, soil conservation, and water management, ensuring that agricultural activities are conducted in a manner that preserves natural resources and supports sustainable livelihoods.





#### Implementation progress for LRA1 - 3 on Conservation Agriculture

The Livelihoods Restoration Program (LRP) successfully scoped 7,278 out of 11,18 PAHs across both the Pipeline (PPL), Project Area (PA), and Main Storage Terminal (MST) sites. During this process, key information such as PAH land parcels, crop choices for planting, and land clearing and preparation requirements were determined. This comprehensive scoping effort enables the LRP to tailor support and interventions to the specific needs of each PAH, ensuring effective and sustainable livelihood restoration initiatives.

Out of the 7,278 PAHs scoped, 4,186 are actively engaged in LRA 1-3 for the current planting season. Scoping activities are advancing steadily to reach all eligible PAHs, concurrently with the implementation of other program activities.

#### REPLACEMENT HOUSING

- A total of 297 houses for pipeline PAPs are complete and have been handed over to their respective PAPs.
- All 297 handed over houses are currently under a one-year warranty period. During this duration, the Project, along with their contractors, is responsible for remedying any defects that may arise from the replacement houses.
- Warranty works are currently at a global progress of 5%.
- Warranty work includes inspecting all 297 houses of any defects, remedying the identified defects and collecting signoffs from PAPs post remedial works to signify the end of their One-Year warranty period.

# STAKEHOLDER ENGAGEMENT – GOVERNMENT AND COMMUNITY

EACOP social team has played a an important role this month, in supporting ongoing project activities. These activities ranged from, the broader engagement within project-affected communities, supporting high-level government visits, high level engagement with parliamentarians as well as supporting other EACOP teams and contractors. Also, the social team has been supporting TPDC's campaign in disseminating awareness messages to village leaders and communities on encroachment of the acquired land.

At the national level, the social team was part of a delegation that met and had interactive engagements with 13 parliamentarians, who are members of the parliamentary public investment committee. The meeting was also attended by representatives from TPDC (Tanzania Petroleum Development Corporation) consisting of 9 individuals and EACOP with 7 representatives present. This engagement arose following the committee's visit to the CY/TIS on the 19th of Feb.


#### Field activities

In February 2024, a total of 457 engagement meetings were conducted, engaging 5,478 stakeholders, of whom 1,801 (33%) were women. The number of meetings increased by 35% from 339 achieved in January. However, the participation of women decreased by 7% compared to January when 40% of

participants were women regardless the higher number of realized meetings in this month. The plan is to conduct women-only meetings especially at community level in the coming months as an initiative to ensure that more women are well informed about the project and the various initiatives.

#### Vulnerable Ethnic Groups Self-Identifying as Indigenous People

In February, engagements with vulnerable ethnic groups identifying as indigenous people were conducted as planned, both by our field team and by NGO-PINGOs Forum. A total of 28 meetings were held, in Manyara, Tabora, Tanga etc. Out of 502 community members engaged, 143 (29%) were women.

Manyara reporting the highest number of meetings and people engaged can be attributed to a high number of these communities in Hanang, Kiteto and Simanjiro districts. However, the number of engaged people increased by 31% from 383 in January. Cumulatively in 2024, a total of 885 stakeholders have been engaged from January to date.

In recognition of the role played by traditional leadership structures among the vulnerable ethnic groups-self identifying as indigenous people, EACOP has maintained its tradition of organising quarterly engagement meetings with traditional leaders. The last workshop was conducted in December 2023 while the next is expected to happen in March 2024.

These meetings aim to share project updates as well as capacitate them so that they can cascade the information to their communities using their cultural platforms. As a result, a total of 17 such meetings were recorded at community level this month, bringing together 1,564 people including 664 women which is 43%.

#### Government Engagements – Regional to Village level

EACOP is yet to conduct the first regional engagement meeting for 2024, pending a response from the ministry of energy regarding logistical entitlements to the government representatives attending the meeting.

However, EACOP is committed to making sure that all our stakeholders at regional and district level are kept up to date. Our field team have continued to engage stakeholders in the meantime depending on their availability and in line with government schedule.

In February, a total of 276 meetings were conducted with government authorities at various levels across 8 project affected regions. This is an increase of 68% from 188 in January.

The meetings included 25 at regional level reaching 153 participants including 37 women, 83 at district level reaching 295 participants including 104 women, 67 at ward level reaching 454 participants including 132 women and 101 at village levels reaching 406 participants including 128 women.

#### **Community Level Engagement**

At the community level, a total of 181 meetings were conducted including 131 meetings with communities reaching 3,727 participants including 1,287 (35%) women while 50 meetings were conducted with individual PAPs engaging 443 people of whom, 113 (26%) were women.



#### **Community Road Safety**

This Month EACOP continued to build on its community road safety awareness campaign through the work done by Tanzania House of Talent (THT) in their execution of phase two of package III in 7 districts (2 regions) while AMEND conducted a field scoping visit as they also continue to prepare for their national round table meeting with government stakeholders on road safety. The event is scheduled to take place on 6<sup>th</sup> March 2024.

THT managed to conduct 18 community awareness sessions at the village level, reaching over 5,500 people including men, women, and children, through their

unique edutainment approach. Some of the testimonials recorded from different stakeholders include, how the approach (theatre and education) brings the community together in initiating discussions on some community problems and challenges such as early pregnancies and reducing road traffic accidents.

The approach has received a lot of commendations from local government, police and community leaders on how it addresses some of the pressing yet sensitive challenges such as road safety and early pregnancies associated with social interactions within host communities.







#### **Grievance Management**

This month, EACOP managed to conduct twenty-seven grievance management meetings both in the field and at the Dar Es Salaam Office (HQ). This includes:

#### **EACOP Toll free number**

The company has continued to receive and record calls through the toll-free number, as part of our efforts to respond to questions, issues, concerns, and grievances as well as receive feedback on matters related to project activities.

In February 2024, 30 calls were received through the EACOP Tanzania Toll-free number about the cadastral survey exercise led by the government (TPDC, Ministry of Energy and the Ministry of Land, Housing and Human settlement) which was completed in the last quarter of 2023.

# Continuation of receiving and recording calls

#### **HUMAN RIGHTS**

The first 2024 Human Rights Steering Committee was held in February.

Three major topics were discussed at the committee meeting.

 EACOP Contractor Workforce management: detailed and accurate monitoring of working conditions is carried out by EACOP's social teams, especially by the Industrial Relations team.

- Vulnerable Ethnic groups: EACOP contractors receive the Protocol to apply with Vulnerable Ethnic Groups self-identifying as Indigenous Peoples.
- Human Rights Defenders: a statement on Human Rights Defenders has been issued by EACOP. We collaborate with CHRAGG in order to address some allegations of threats, intimidation, harassment or violence against Human Rights Defenders in relation to its activities EACOP.



## **PROJECT INDUCED IN-MIGRATION (PIIM)**

From ongoing EACOP's efforts in managing PIIM and its associated negative impacts, the Q1 PWG meetings in the hotspot's locations identified in the PIIM Situation Analysis, it was confirmed that there were some number of In-migrants noticed in some areas but at a very low scale so far.

In some areas such Bukombe, Mkungo and Kagongwa, theft behavior on property/assets, the use of alcohol & drugs issues and commercial sex activity have been noticed.

However, the village leaders in collaboration with EACOP (Community Relation Supervisors- CRSs and Community Relations Coordinators - CRCs) are engaging communities



around the site for awareness and to remind the EACOP rules on the recruitment process: 100% unskilled positions are for affected community's members in priority.

#### **IMAGERY ACQUISITION**

The report regarding Buildings Change Detection for Q1 -2024 indicates some development with few new Structures/Buildings in some hotspot's locations including MTT/MST in Tanga. Field verifications are conducted to confirm the nature of the changes and if they are related to PIIM or not and their potential negative impact to Community, Government and to EACOP in the area.

Thanks to field teams (CRS and CRC) on their daily monitoring of the detected building in case of any changes from initial plan of such as from being a Residential house to Guest house or Restaurant and if the changes will have some potential negative impacts related to PIIM to both Community, Government and to EACOP. The findings will therefore help the Government and EACOP to collaborate and plan for collective measures.


Continuous monitoring of active sites assures compliance with permit conditions and regulatory requirements, resulting in smooth and compliant project execution.

#### **GV-Permits Received This Month from CTRS**




#### **GV All Permits Acquired by L1 Contructors**

The Tanzania Chamber of Commerce, Industry, and Agriculture (TCCIA) has confirmed the TIS plant site visit for the Certificate of Verification.




## **Regulatory Compliance and Assurance**
