East African Crude Oil Pipeline (EACOP) LTD ("COMPANY") invites experienced and reputable Companies to express their interest in the Provision of Consultancy Services for Assessment and Compensation for Unviable Residual Land to the East African Crude Oil Pipeline (EACOP) Project. The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula, Tanga Region, in Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda.

## BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

COMPANY invites suitably qualified companies to express interest in the provision of recruitment consultancy services.

Services will include:

- Propose shortlisting criteria per vacancy.

- Proof of registration to the National Supplier Database (NSD) maintained by the Petroleum Authority of Uganda.
- Compliance statement of the Local Content Regulations, 2016 and Local Company definition.
- Proof of Anti-corruption, Anti-bribery, Compliance and Human Rights policies.
- Financial capacity to deliver the services required including the submission of audited financial accounts for the last two years.
